**INVITATION TO BID**

The Securities and Exchange Commission (SEC), through the General Appropriations Act of the CY2015 Annual Procurement Plan intends to apply the sum of **One Million Three Hundred Thousand Pesos (P1,300,000.00) inclusive of VAT and other applicable taxes** being the Approved Budget for the Contract (ABC) as payment for the **Rental of Two (2) Brand New Units of Microfilm Reader/Printer Machine (With No-Operator)**. Bids received in excess of the ABC shall be automatically rejected during the bid opening.

SEC now invites bids for the **Rental of Two (2) Brand New Units of Microfilm Reader/Printer Machine (With No-Operator)**. Bidders should have completed, within three (3) years prior to the deadline for the submission and opening of bids for this project, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from SEC BAC Secretariat and check the Bidding Documents at the address given below during office hours from 8:00am – 5:00pm.

A complete set of Bidding Documents may be obtained by Interested Bidders starting **June 15, 2015** from the Procurement Division, 4<sup>th</sup> Floor, SEC Building, EDSA Greenhills, Mandaluyong City, upon payment of a non-refundable fee of Five Thousand Pesos (P5,000.00), pursuant to the latest Guidelines issued by the GPPB.
