For this purpose, similar contracts shall refer to the "Services rendered involving conversion to digital format; storage and retrieval; viewing; and printing"	The Bidder must have completed, within the period specified in the Invitation to Bid and ITB Clause 12.1(a(ii), a single contract that is similar to this project at hand and whose value must be at least fifty percent (50%) of ABC. In lieu of the above, the Bidder may opt to submit at least two (2) similar contracts, which the aggregate contract amount should be equivalent to at least fifty percent (50%) of the ABC, within five (5) years prior the deadline of submission and receipt of bids for this project. The largest of these similar contracts must be equivalent to at least (25%) of the ABC. Bidder shall include in their bids: 1) A photocopy of approved Contract/Purchase Order/Work Order; and 2) Certificate of Completion or Acceptance from bidder's client; of Official Receipts/s of the bidder covering the full amount of the contract. Index Format	Q: Will you show or provide the Index Format (e-PLDT)? It should be included in the TOR.
	-The SEC can provide the Index Format, the bidder can request before the Submission of Bids
On-Line Document Retrieval System	Q: Is it the same as SEC I-view (Vibal)?
	-It is an Alternative/Back up-system for SEC I-view.
Legacy System	Q: Is the Legacy System indicated in the TOR(e-PLDT)?
	-The SEC can show the prospective bidder/s, how the Legacy System (SEC I-view) works. The SEC will schedule a walk through for this, but first the bidders must secure the bidding documents.
Single Largest Completed Contract	Q: What contracts/projects can be indicated/stated as part of the Single Largest Completed Contract? If it's okay that aggregated contracts be accepted?
	-For this purpose similar contracts shall refer to the "Services rendered involving conversion to digital format, storage and retrieval; viewing; printing."
	-The BAC will allow an aggregated contract that has the four requirements.
