



**INVITATION TO BID
(SEC PB No. 2020-023)**

The Securities and Exchange Commission (SEC), through the authorized appropriations under the FY 2020 Revised Corporation Code (RCC) intends to apply the sum of **One Million Seven Hundred Sixty-Four Thousand Pesos (Php1,764,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract **Supply and Delivery of Equipment for Information Officers at the SEC Extension Offices**. Bids received in excess of the ABC shall be automatically rejected during the bids opening.

SEC now invites bids for the project, **“Supply and Delivery of Equipment for Information Officers at SEC Extension Offices**. Delivery of the Goods shall be in accordance with Delivery Schedule under Section VI. Schedule of Requirements. Bidders should have completed, within five (5) years prior to the deadline for the submission and opening of bids for this project, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA 9184), otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or corporations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from the SEC-BAC Secretariat and inspect the Bidding Documents at the address given below during office hours from 9:00 a.m. to 4:00 p.m.

A complete set of Bidding Document may be acquired by Interested Bidders starting **September 23, 2020** from the address below, upon payment of a non-refundable fee of One Thousand Pesos (Php 1,000.00).

It may also be downloaded free of charge from the Philippine Government Electronic Procurement System (PHILGEPS) and SEC websites, provided that the Bidder shall pay the applicable fee for the Bidding Documents not later than the submission of bids,

All bids must be accompanied by a Bid Security in any acceptable forms and in the amount stated in ITB clause 18. It will be opened in the presence of the Bidders' representatives who choose to attend at the address stated above. Late Bids shall not be accepted.

The SEC reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA No. 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
